To assist you in the final steps of your purchase we outline some pertinent information.

TELEPHONE

As Solicitors, we do not attend to the connection of your telephone service. Installation and reconnection information can be obtained from your local Telstra Business Office.

The local Telstra Office is listed in your White Pages Telephone Book.

We would suggest that you contact them prior to settlement to advise the date that you commence occupation of the premises. You are not responsible for the previous owner's billings.

ELECTRICITY

Energex connections may be made by telephone and is usually carried out within 48 hours. You can telephone them on 13 12 53 and ask for reconnections and quote your new address.

GAS

For gas connections also telephone Energex on 13 12 53. They will be able to reconnect your facilities.

POST OFFICE

Your nearest post office can provide you with a relocation pack. You can also phone 13 13 18 to receive this information pack. The pack contains all relevant information concerning services that can be made available to you.

We suggest that you should have your mail re-directed from your old address. This can be arranged through the post office for a small monthly fee.

DRIVERS LICENCE AND MOTOR VEHICLE REGISTRATION

Queensland Transport offices can attend to the changing of your new particulars. Notification of your change of address should be carried out within 14 days. You can either contact your local office near you or you can telephone Queensland Transport on 13 23 80.

ELECTORAL ROLL

The Electoral Commission of Queensland can be contacted on 3227 6444. They will send all the necessary forms to you to cover both State and Commonwealth Elections.

TAXATION

The Australian Taxation Office should be advised of your new address.

GARBAGE

We will notify the Council of your new purchase. We suggest that you contact your local council's Engineer's Department so they can advise you of their services.

CREDIT CARDS

It is advisable to notify the relevant companies with whom you currently hold Credit Cards of your new address.
